


























Clinical Legal Educational is an experiential based education whereby students learn by doing:

MAU are known to have a very comprehensive learning moduled in CSA, thus our collaboration has always allow COP to dive deeper on CSA topics/contents.









- Yayasan Chow Kit (YCK) is an NGO that caters to the needs of children and teenagers in and around Chow Kit.
- They currently run two drop-in centres within Chow Kit and one safe home for children who are in need of temporary guardianship.
- KL Krash Pad, a centre under YCK caters to teenagers aged 13 to 18 years old, providing a safe space for teens to engage meaningfully and productively with their peers.
